Best Practice – Intrastate Relocations

- Chair Connor reported she received an email from the Rules Committee Chair requesting that the Training Committee develop a best practice on the topic of intrastate relocations in the receiving state after acceptance of supervision. At the request of the Rules Committee, each region provided feedback on the way they currently handle intrastate relocations. The general consensus was when the family dynamics changed, a home evaluation was requested. When juvenile relocated with the approved family, the receiving state's protocol is followed and the Quarterly Progress Report updated.
- Chair Connor, T. Marchand (NC), M. Pressley (SC) and C. Samuel (TN) volunteered to draft a best practice.

Best Practice – Form IA/VI

- G. Soja (OR) updated that the Form IA/VI Best Practice and Advisory Opinion 02-2015 conflict and that the issue was shared at the last Rules Committee meeting.
- T. Marchand (NC) suggested the Training Committee revisit the best practice to address the conflict. Chair Connor, G. Soja (OR), A. Ehlers (ID), and J. Regis (DC) volunteered to review the best practice and make a recommendation.
