## Unfinished Business

### Report from Human Trafficking Subcommittee

- Vice Chair B. Montelongo (CO) stated that the Human Trafficking Subcommittee discussed adaptive and technical problems regarding making the human trafficking field in UNITY

mandatory. The members also discussed sending questions to each region to see how states respond to human trafficking.

- Director Underwood added that Shared Hope International tracks information about human trafficking laws. A link to the Shared Hope resource will be added to the Commission's website so that states no longer need to update the human trafficking matrix.
- Director Underwood reported that Ohio is focusing on conducting human trafficking screenings. She recommended that Commissioner S. Lane (OH) reach out to the Human Trafficking Subcommittee.
- Committee members discussed methods for presenting questions to states, including polling and group discussion. Chair M. Casey (DE) shared that he will present the idea of polling the regions to the Executive Committee for approval.

#### **Report from Movie Club Subcommittee**

- D. Liedecke (TX) shared that the Movie Club Subcommittee will meet on the last Friday of each month to watch and discuss the film of the month. The first four movies selected were:
