### **Unfinished Business**

### Discuss 2025 Annual Business Meeting Training Sessions

- Amanee Cabbagestalk, National Office, reported she met with Dr. Nicole Price, the Chief Executive Officer of Lively Paradox, about being the keynote speaker for the 2025 Annual Business Meeting (ABM).
- J. Hall (FL) made a motion to recommend Dr. Nicole Price for the Keynote Speaker at the 2025 Annual Business Meeting to the Executive Committee. The motion passed.

- Chair R. Heide (AK) stated that the Work Group on Non-Delinquent Youths was slated to present a training session at the 2025 ABM. He said a presentation related to returns has been prepared but may not suit everyone's needs. Amanee Cabbagestalk (National Office) explained it is an informational presentation about returns. She recommended providing a shorter version and advising attendees about how they can use it to train other personnel in their states.
- R. Gallardo (UT) suggested adding a training regarding tribal nations at ABM. He referenced the Racial Diversity, Equity, and Inclusion (RDEI) Committee's work and data suggesting disparities in denial of home evaluations for Native American youths. He stated it would be helpful to learn the legal aspects of whether states can hold youths on tribal warrants pursuant to the ICJ and how to work with Tribal Nations.
- Amanee Cabbagestalk, from the National Office, stated that the RDEI Committee has plans to work on a *Quick Reference Guide on Tribal Relationships* and could possibly present it at the ABM. Members agreed with this idea.
- Chair R. Heide (AK) stated that he would contact the RDEI Committee to discuss their presentation at the ABM. He will update the Training Committee at the next meeting.
- He asked members to contact him if they would like to assist on a Training Subcommittee to continue planning the training session for the ABM.
- Amanee Cabbagestalk, National Office added that Amy Ast, Ohio Department of Youth Services Director, will present the welcome address at the Annual Business Meeting.
